If application is approved, Applicant understands that they will be required to sign an Agreement for Private Crossing, which will provide that Applicant will: (1) perform all grading of approach roads and install culverts and gates to meet Railroad engineering standards, (2) reimburse Railroad for construction and maintenance of the crossing, erecting required signs, altering pole line if required, and removing the crossing and approach grades if the crossing is temporary or if the agreement is later cancelled, and (3) furnish liability insurance as stated in the Agreement.

Applicant will be responsible for keeping gates closed, rail flangeways free of obstruction, and vegetation cut in all four quadrants. Applicant will attach location sketch showing pertinent details and North arrow.
